Aspirations-- what inspires us, guides us, and leads us to make the world a better place.

We hope you enjoy reading about the aspirations of Wabash County citizens who, with the Community Foundation, accomplished things that never were—support for first responders, post-secondary scholarships for fourth-graders, a groundbreaking playground that redefines what it means to be inclusive, a river made cleaner, more early childhood seats, and a growing repository of charitable capital to address the ever-changing needs of Wabash County.

The Foundation has grown significantly since its founding in 1954. We closed 2020 with over \$67 million in assets and since January 2018 awarded over \$7.5 million in grants and scholarships. We were pleased to support new service agencies in Wabash County, BABE of Wabash County and Hope House, and fund new homes for others, Lighthouse Missions. We are profoundly grateful for citizens who dare to dream, give generously of their time and treasure and invite us to participate.

In response to Lilly Endowment GIFT Phase VII, the Foundation earned \$500,000 in discretionary funds and the board successfully met the Endowment's board giving challenge affording another \$100,000 for discretionary spending. Joining forces with Grow Wabash County, the Foundation engaged the Community Research Institute, Purdue FW to conduct a multi-faceted study of the County's 40-year steady and menacing population loss. We conducted On the Table conversations with over 400 citizens. From these extensive studies, we were awarded Lilly Endowment planning and implementation grants and convened representatives from the City of Wabash, the County and all incorporated towns to create a 25-member steering committee, which has embarked on an 18-month process, Imagine One 85 to develop a county-wide comprehensive plan aimed at growing population.

Who would have guessed in 1990, as the Lilly Endowment encouraged Indiana counties to build unrestricted endowments that one of the ever-changing needs would be to respond to a virus. We are grateful for the many Wabash County citizens who have unselfishly contributed to our unrestricted endowments, which afforded the Foundation the resources to pivot our grantmaking and create the Covid-19 Relief and Restore Fund to help citizens who were financially disadvantaged by Covid. In this period, the Foundation earned accreditation by National Standards for Community Foundations, a seal which demonstrates a commitment to operational excellence. We remember that your trust and confidence is our most treasured asset, and we look forward to the future in our new old home at 220 East Main Street, where we endeavor to maintain the highest standards in practice and service to realize aspirations and cherish values for all of Wabash County--- Helping good people, make good things happen for Wabash County.

EARLY AWARD SCHOLARSHIPS

While the Community Foundation of Wabash County has for decades been dedicated to promoting education in families across Wabash County, in 2012, through a strategic planning process, the **Community Foundation board** prioritized educational attainment as the county's most pressing need, as it is the principal driver of economic opportunity and relief from poverty. At the same time, the Wabash County YMCA created the Wabash County Promise, which has as its aim to empower every youth to reach their full potential and to close the achievement gap in low-income families.

The Wabash County Promise focuses on enrolling every Wabash County student in grades K-3 in a children's savings account – Indiana's CollegeChoice 529 Plan – by offering each student the opportunity to open an account through school channels. The results in the program's first year were impressive: more than 55% of students in grades K-3 opened an account. This was an exciting start, but what steps might the community take to ensure students and families of all income levels continue to prepare and build assets for future education – between 3rd grade and senior year, when our students aspire to acquire skills needed for a livable wage and productive lives?

To answer this question, the Community Foundation examined its experience as a longtime administrator of traditional scholarships. Typically, students begin aspiring to attend technical school or college near the end of their high school careers. But by this time, many students do not even apply for scholarships because they did not conclude from a young age that their future is dependent upon their education. Born of a commitment to nurture young students' college-going identities, and to help them connect their efforts in school with their ability to attend technical school or college, the Community Foundation developed the Early Award Scholarship Program. Designed in partnership with Wabash County educators and funded in part by the Charles Stewart Mott Foundation, the program is available to all 4th-8th grade students who attend a Wabash County school.

The Early Award Scholarship Program provides financial awards for inschool achievements in math, reading, language arts, and completion of college-preparation activities and savings matches for deposits to students' CollegeChoice 529 Direct Savings Accounts. The awards are deposited quarterly into each student's Early Award Scholarship Fund, managed by the Community Foundation. For maximum effect on a child's identity and on their family's expectations, achievements are recognized in the newspaper, on social media, and at school sporting events. Families receive a Progress Report and Fund Statement each quarter showing the scholarships awarded to the student's Early Award Scholarship Fund and the associated investment activity. After graduating from high school and enrolling at a qualifying post-secondary education institution, students may present a tuition bill to the Community Foundation and request a grant from their Early Award Scholarship Fund directly to that school.

Wabash County students who participate in Early Award Scholarships have:

- Higher state assessment scores
- Stronger college-bound identity
- Improved socialemotional health
- A pattern of saving more money, and saving more often

Early Award Scholarships

Participating Wabash County students can earn up to \$1,000 in scholarships through completion of the program in grades 4-8. Now in its 5th year, the Community Foundation has opened funds for more than 1,900 Wabash County students. The combined assets of these funds total more than \$760,000.

While it is exciting to watch the rise in students' Early Award Scholarship Fund balances, the Community Foundation knows that children's savings accounts are more than financial instruments. As investments in economic mobility, children's savings accounts are transformative, asset-based interventions with demonstrated ability to improve outcomes for children and families on a variety of measures: academic, social/emotional and financial. Rigorous, randomized-control examinations of programs that facilitate early ownership of educational assets, as in children's savings accounts, has found that assets improve the social-emotional development needed to succeed academically.

Children's savings accounts mitigate about 50% of the negative association between material hardship and children's social-emotional development. A low and moderate

income child who has school savings of \$1-\$499 prior to reaching college age is over three times more likely to graduate from college and four times more likely to graduate from college than a child with no savings account. In addition to these findings on the impact of children's savings accounts throughout the nation, research specifically on Wabash County students who participate in the Early Award Scholarship Program shows that these students have higher state assessment scores, stronger college-bound identity, improved social-emotional health, and a pattern of saving more money, and saving more often. Effects are strongest among low income students.







"Across the country, the idea of children's savings accounts is starting to build momentum, and as that momentum builds, we are eager to gain a better understanding of what makes a program work well and how communities can come together to raise and support children's educational aspirations. Through grants to organizations like the **Community Foundation of** Wabash County, Mott is seeking to tease out best practices that will help us take this idea to scale. We believe if we can get more kids and more accounts, we will begin to uncover additional positive impacts on education."

ENROLLING YOUR STUDENT IN THE COMMUNITY FOUNDATION EARLY AWARD SCHOLARSHIP PROGRAM

All 4th-8th grade students are encouraged to participate in the Community Foundation Early Award Scholarship program. By completing in-school assignments and making regular savings deposits, students can earn scholarships to pay future post-secondary education expenses.

Parents must enroll their 4th-8th grade student in the program before they can begin earning scholarships. Participants must have a CollegeChoice 529 Direct Savings Account and a completed Participation Agreement Form. Enrollment forms can be found online at www.cfwabash.org. DONOR SPOTLIGHT: RALPH NARAGON

Ralph Naragon had a long and influential history with the Community Foundation of Wabash County, and because of his charitable way of life, his legacy will live on in perpetuity. The Community Foundation is extremely privileged to have had Ralph's loyalty and service for over four decades. His significant contributions have shaped the Community Foundation as well as the lives of Wabash County residents.

According to attorney Al Schlitt, one of Ralph's longtime friends and business associates, "Ralph played a large role in the success of the Community Foundation. He had a good business sense, and frequently advised clients on estate tax planning and directed them to the Foundation to help meet their needs." Many of the Foundation's endowments were created by Ralph's clients.

Of the many attributes that Ralph is remembered for, one major quality was his generosity - not only with money but also with his time. "Ralph lived to serve and serve his community," said Becky Naragon, Ralph's wife. "Material things were not important to him." Becky noted that many times, Ralph referenced and lived his life as it reads in Luke 6:38 "Give and it will be given to you. Good measure pressed down, shaken together, and running over, will be given to you. For the same measure you use, it will be given back to you."

Ralph was a Certified Public Accountant at Gilbert & Naragon, during which time he developed countless client relationships and friendships. Becky, who worked for Ralph for a time, recalls that "Ralph's clients often became his friends. He valued the relationships he was able to form through his work, and expanded them beyond his professional responsibilities. He built strong connections and was extremely loyal to his friends."

One client in particular that Ralph became close with was the late Paul L. Speicher, who is credited with the invention of the broadcast spreader on wheels. Paul was a longtime client of Ralph and sought his council with his estate planning. Paul decided that he would, in his will, create the Paul L. Speicher Foundation with his estate, to which he named Ralph the sole trustee. Upon Paul's passing in 1999, Ralph began managing the Speicher Foundation, which annually supported areas and programs that were important to Paul. Under Ralph's guidance, this support reached the Community Foundation through the creation of three endowments: Paul L Speicher Foundation Good Deeds Endowment (2002), Paul L. Speicher Administrative Endowment (2002), and the Paul L. Speicher Foundation Aquatics and Fitness Center Endowment (2011).

DONOR-ADVISED FUNDS — ENDOWED OR NON-PERMANENT

A FLEXIBLE GIVING OPTION FOR DONORS WITH MANY INTERESTS

Creating a donor-advised fund provides you with the benefits of having your own private foundation without the burdens. An advised fund at the Community Foundation is a flexible, low-cost, convenient and local solution to supporting your individual charitable interests. Donor-advised funds can also offer anonymity.

An advised fund allows for ongoing input from the donor or the appointed advisor, which provides opportunity to award grants to a single or wide variety of organizations and programs. Donors can appoint children, grandchildren or other individuals as the fund's advisor. The Community Foundation assists donors through council, research, reporting and management of donor-advised funds.

This type of fund is ideal for donors who wish to support a multitude of different charitable causes, or who wish to be hands-on and reactive to the needs of the community.

Al and Becky no longer faced the challenges and cost of administering the trust, and the funds would never cease or need to be transferred to new trustees. Additionally, the Community Foundation is dedicated to upholding the original donor's intentions. Now, Becky and Al can serve as advisors to the fund by making grant recommendations that continue Paul's vision and adhere to his values.



EARLY CHILDHOOD

Research shows that for every dollar a community invests in early childhood education, the return on investment to the community can be \$4-\$15 due to increases in post-secondary attainment associated with high-quality early learning, higher incomes over a lifetime and therefore more tax-paying and more contributions to the local economy, lower special education costs, reduced costs for social services, and lower costs for retention. In 2016 alone, Wabash County spent \$121,107 to retain children in kindergarten who were unprepared to learn. High-quality early learning programs save money in the long-run.







Wabash County is home to 2,000 children under the age of six. Where do these beautiful young citizens spend their days during the first years of life? For the most part, they are with a loving parent, family member, friend, or sitter. Around 320 children are enrolled in our county's licensed homes, centers, and registered ministries, which means 77% of our children who need care are not enrolled in a known programs.

The first five years of children's lives are critical to their future development. Their brains are developing with explosive speed, and the more exposure they get in their early years to experiences, interactions, language, and exploration, the more agile their brains will be as they enter school. When introduced to the world at birth, the brain begins making millions of connections, especially when that brain is placed in a growing environment, full of new sounds, sights, and experiences. These interactions could take place with Grandma or they may occur at a Level 4 preschool.

Early Education in Wabash County is making important progress in providing education-rich childcare for our developing children. Eleven childcare and early education programs in Wabash County participate in Indiana's voluntary rating system, Paths to Quality. Five rated programs have achieved a high quality rating of level 3 or 4. Two more programs will be rated soon and certified at level 3 within the year. This is exciting progress, but we still have a big gap between the families who want or need services for their children and those whose children are enrolled.

The Community Foundation is committed to increasing access to high quality early education programs where all parents, but especially parents who work, can be certain their children are in a reliable place with a quality educational environment. Families who use rated programs miss less work because of childcare crises. If childcare is affordable, they can stay in the workforce while raising young children. Those that stay in the workforce receive many more years of wage increases and job training. Employers can realize greater productivity from employees, better retention, and better return on the cost of training employees when their employees use licensed, registered childcare.

45% of parents are absent from work annual at least once due to childcare issues.
65% of parents' work schedules are affected by childcare challenges an average of 7.5 times annually.
These childcare challenges cost U.S. employers an estimated \$3 billion annually.

A coalition of early education stakeholders called First Five Wabash County has developed a strategic plan focused on increasing the availability and affordability of high quality early childhood education programs for children age 0-5 in Wabash County. The strategic plan has five key goals: 1) Increase Capacity, 2) Increase Accessibility, 3) Improve Quality, 4) Improve Affordability, and 5) Increase Parent and Community Engagement.

The Coalition hopes to strengthen the career pathway for adults seeking certifications and degrees in early childhood education. Traditionally, caring for children has been low-wage work. Early educators who gain a credential can expect to earn little more than those who have no credential. The Coalition's strategic plan also calls for developing a funding model for early education programs that provides affordable care and compensates certified educators well. Lowering overhead, developing a scholarship program, instituting sliding fees for service, and accessing vouchers for families and financial aid for college-level training are some of the ways that the community can provide more affordable care without sacrificing quality.

Without a doubt, early childhood care and education is important to Wabash County. The Community Foundation and the Early Childhood Coalition will continue to implement strategies to improve the early childhood sector and make progress towards a better Wabash County.

FIRST RESPONDERS

When contemplating your legacy, will you consider a gift to your favorite charity?

In 2016, the Community Foundation received a testamentary gift from community minded Wabash County citizens, Gordon and Audrey Ridenour. Mr. and Mrs. Ridenour established the Gordon and Audrey Ridenour First Responders Endowment to benefit the work of first responders who voluntarily risk their lives to help others. The Fund provides grants to cover the costs of equipment, supplies, training, and other expenses not covered by their department budgets.



Upon Gordon and Audrey's passing in September 2016 and May 2016 respectively, the Ridenour estate funded their endowment to assist in perpetuity the efforts of first responders in Wabash County. The Wabash County groups available to apply for funding from the Ridenour Endowment include Emergency Medical Services (EMS), Fire Departments, City Police Departments, and State Police serving the Wabash Area. In 2020, the Ridenour Endowment provided funding to Wabash County first responders in order for them to provide emergency go-bags for every classroom in Wabash County. The go-bags included items such as compression bandages, a tourniquet, flashlights, rubber gloves, and other first aid items that could be needed during an emergency.

In 2015, the Foundation also received a testamentary gift from Kathleen Daywalt to establish the John W. Daywalt Scholarship Endowment, and another from A. Eileen Meyer that benefited the Community Foundation's grantmaking. Each of these donors' gifts will continue to provide support for the causes they felt most important, even though the donors are no longer with us. Through each donor's gift to the Community Foundation, their legacy will live on forever and help countless people in Wabash County.

Individuals who leave testamentary gifts to the Community Foundation of Wabash County become members of the Mary Louise Little Legacy Society, named after North Manchester native Mary Louise Little. Ms. Little served as President of the Community Foundation and left a portion of her estate to the Foundation. Donors who name the Community Foundation in their wills, or as the beneficiary of life insurance policies, retirement accounts, gift annuities, or charitable trusts, will leave a legacy of giving by supporting their interests in perpetuity.

Bequest

With the help of an attorney, you can include language in your will or trust specifying a gift to be made to the Community Foundation as part of your estate plan. Irrevocable future gifts may provide current tax benefits. You can designate the Foundation as a full, partial, or contingent beneficiary of your retirement account or life insurance policy. With the bequest, you can also create a fund in your name or contribute to an existing fund.

Charitable Gift Annuity

A charitable gift annuity allows you to transfer cash or property to the Community Foundation, and in exchange, we pay you (or your designated annuitant) fixed payments for life. You will also receive a charitable income tax deduction.

WABASH RIVER DEFENDERS

In 2017, the Wabash River Defenders submitted a grant proposal to the **Community Foundation** for a two-year plan that would conduct a baseline investigation into water quality of the tributaries feeding the Wabash River. This plan would require the purchase of equipment and the engagement of an independent watersampling contractor. Additionally, the organization sought to hire an executive director to aid long-term sustainability of the organization.

Established in 2010, the Wabash River Defenders seek to improve the aesthetic and ecological conditions within the Wabash River. The organization arranges river clean up events, adult and youth-based education and outreach, habitat restoration, trail and campsite improvement, and community engagement.

The Wabash River
Defenders engages
300+ volunteers
annually who have
worked to clear 292,000
pounds of tires, scrap steel, construction
and other materials from the river clean-up
events. They have also worked to reduce
public dumping by getting a trash-dumping
ordinance passed and placing signage
around the county.

From the grant in 2017, the Wabash River Defenders purchased equipment that enabled them to execute two significant projects to collect and record a variety of water quality parameters. The data collected established a baseline to evaluate the quality of water flowing in the Wabash River, and the analysis of the data was used to create an extensive management water plan. The plan is critical for the Wabash River Defenders to apply for additional funding through large funding organizations such as the Indiana Department of Environment Management and the Indiana Department of Natural Resources. Steve Johnson, a member of the Wabash River Defenders said, "The \$12,000 Community Foundation grant went well beyond any short-term benefit. The grant resulted in an investment of hundreds of thousands of dollars and hundreds of volunteer hours in the work of water quality improvement in the Wabash River watershed in Wabash County."

Because the Wabash River Defenders is a nonprofit organization serving a charitable activity in Wabash County, they represent an organization eligible to apply for a Good Deeds Grant. Today, the Wabash River Defenders are continuing the good work of improving our environment and our rivers.

APPLYING FOR GRANTS

Organizations serving Wabash County can apply for grants from the Community Foundation through the Good Deeds Grant Program in the spring and fall. Good Deeds Grants are small to mid-sized grants that help nonprofit organizations meet the basic needs of Wabash County citizens and provide enrichment experiences for those with limited resources and opportunities.

Good Deeds Grants may be used in any area that fills a basic human need, creates opportunities for people who ordinarily do not have them, or increases the capability of a nonprofit organization to serve people who have limited resources and opportunities. Some of the areas supported by Good Deeds Grants include the arts, recreation, health and human services, the environment, education, and civic and economic development.

Good Deeds Grants are made available from Good Deeds endowments, which are unrestricted endowments created by contributions from Wabash County citizens and Lilly Endowment, Inc. These donors elected to provide for the changing needs of our county by not restricting the purpose of their endowed gifts.

Applications for Good Deeds Grants are available through the Community Foundation website (www.cfwabash. org) and are reviewed twice each year. Organizations are only eligible to receive one Good Deeds Grant per calendar year. The application deadlines are March 15 and September 15.



INCLUSIVE PLAYGROUND


When the inclusive playground project first began, the Community Foundation of Wabash County served as a fiscal sponsor to the Wabash Inclusive Playground. As one of many services to the community, the Foundation assists groups who wish to complete charitable work, but that need assistance with fundraising, because they do not have 501c3 exempt status. Having 501c3 exempt status allows the organization or group to provide its donors with charitable tax receipts for their gifts. By serving as a fiscal sponsor, the Community Foundation assists community groups whose donors may want a charitable tax deduction in addition to the Foundation's oversight to ensure their gift is used as intended. The Foundation then funds the sponsored organization's project through those gifts.

The community rallied behind the project and the Community Foundation received hundreds of individual gifts for the benefit of the Inclusive Playground. Now called Friendship Hill, the playground is located in downtown Wabash and brings people of all abilities and all ages together. Unlike a traditional park, the inclusive play model allows individuals the freedom to play, explore, imagine, and create without limitations. Children are provided the opportunity to look beyond each other's abilities or disabilities and equally experience the world of play. By opening the door to understanding and opportunity, the lives of our children and our community are enriched.

ADVANCING TALENT

Wabash County strives to be more than a weekend getaway, but rather, a place to call home. Many organizations and initiatives, such as the **Imagine One 85 countywide** comprehensive plan, aim to make Wabash County appealing to employers, businesses, and homeowners in the midst of a steady population decline. At the core of attracting individuals to Wabash County and retaining the talent already here, is the ability to provide diverse employment opportunities. To obtain these businesses and employers, we must provide a qualified and talented workforce, which has proven to be a challenge for our county.







By 2025, 60% of jobs in Wabash County will require education beyond high school. However, only 35% of Wabash County residents currently have post-secondary education. In order to meet the demands of the future workforce, an average of 250 middle-skills workers must enter the workforce every year These middle-skills jobs, including semi-truck drivers, electricians, plumbers, welders, and cosmetologists, require some extent of training or education after high school, which could include a 2- or 4-year college education or a certification program.

The Community Foundation is dedicated to supporting programs that equip individuals with the skills and certifications needed for these jobs. In 2019, the Community Foundation made a grant to Heartland Career Center and Ivy Tech, who had partnered to offer a commercial driver's license (CDL) class A licensure program for high school students and adults. The CDL program would help students gain the skills needed to obtain a class A license, which would enable them to operate any commercial vehicle including tractor trailers and livestock carriers, as well as food and delivery trucks. In 2020, the first class of seven high school students completed the program and received their CDL licenses. Trucking is one of Wabash County's high demand careers, and now, these students are ready and prepared to enter the workforce.

Wabash County is privileged to have innovative adult education organizations that work to increase and develop the skills of our county's current workforce. Some of these organizations include the Learn More Center and Ivy Tech. The Learn More Center assists adult learners with literacy and obtaining their high school equivalency diplomas while Ivy Tech provides college courses as well as workforce training and certifications for people already in the workforce. The Community Foundation looks forward to the creation of the new Heartland Learning Center, planned to open in 2022, which will provide secondary and post-secondary educational training opportunities for students of all ages in Advanced Manufacturing and Healthcare.

The programs listed above are but a few supported by the Community Foundation to raise the educational attainment level of Wabash County citizens and prepare them to fill the needs of the workforce. It is our goal that with a qualified workforce, Wabash County will attract employers, businesses, and individuals to not only grow population, but also to grow talent. And when our residents are better educated, they can secure better jobs, earn higher wages, and live a more prosperous life. THIS is what we want for all of Wabash County.

Through the endowments at the Community Foundation of Wabash County, you can support education, the arts, your church... or whatever aspect of life you hold most dear and wish to nurture and financially support. Forever.

How do endowments work?

The simplest explanation of an endowment is that it is a way to financially provide in perpetuity for the people, places, and organizations of this community that are dear to you. An endowment is established through a charitable contribution to the Community Foundation. We don't spend your gift; we save it and invest it wisely to grow and produce earnings. Through an endowment agreement, executed at the time or your donation, the Foundation agrees to distribute a portion of the endowment's earnings to the designated charitable entity or cause you care most about. Distributions are called grants. Only a portion of the earnings are distributed in order to allow your fund to grow over time. As time passes, grants from your endowment will exceed the value of your original gift.

Why use the Community Foundation endowments as a vehicle for giving?

By giving through an endowment, you decide to provide support into the future. By using the Foundation, you are afforded the most efficient, flexible, and convenient means to support your individual charitable interests. Giving through the Community Foundation is local, it's low cost, flexible, and convenient. A named endowment created by you is like having your very own private foundation without the burdens. We take care of all the administrative services you would need, including the annual audit, IRS filings, grant evaluation and compliance, and financial reporting. Additionally, your endowment benefits from being invested with other Community Foundation endowment assets, resulting in lower investment fees and greater investment diversification. And lastly, you direct us regarding the degree of anonymity or recognition you require and the degree of specificity in grantmaking.

There are five types of endowments: unrestricted, designated, field of interest, scholarship, and donor-advised. Additionally, the Foundation offers two types of non-permanent funds: Special projects and donor-advised. Currently, the Foundation administers over 350 funds, and you can read about them and the great work they do in the following pages.

You can create an endowment to be named for a family member or loved one, in honor of, or as a memorial. An endowment can be created anonymously. You can direct the grants from your endowment broadly or narrowly to issues you care about or to wherever the needs are the greatest.



UNRESTRICTED ENDOWMENTS

Unrestricted endowments are endowments whose earnings are not designated or restricted to an organization of specific purpose, but rather are free to support a program of perpetual grant-giving designed to respond to the ever-changing needs of our community. Distributions from these endowments, called the Good Deeds Endowments, are available to the community by application and are awarded at the discretion of the Community Foundation.

The scholarship is awarded to individuals who exhibit kindness, eagerness, happiness, and a positive and independent "can do" mental attitude, just like Sarah's.

Heartland Career Center Scholarship is awarded to senior students of Heartland Career Center who wish to continue their career education and training beyond high school.

William B. Hensley III Memorial Scholarship Endowment was established in 2008 by Cindy, J.R. and Todd Hensley, along with family friends, to honor and memorialize William and his love of athletics. Scholarship recipients will have graduated from a Wabash County high school and be a collegiate sport participant.

Richard L. & Marna L. Hettmansperger Scholarship Endowment was established by Mr. and Mrs. Hettmansperger to support graduates of any Wabash County high school entering an accredited graduate school to study in the area of Christian ministry or mission.

Raymond C. & Martha Ross Hood Scholarship was established by retired elementary school teacher Martha Ross Hood. Martha created the scholarship to help deserving students build the means to take care of themselves and their families.

Raymond C. & Martha Ross Hood Scholarship Endowment for Accounting Studies provides scholarship support for students who are accepted into and attend on a part-time or full-time basis, a two- or four-year Indiana public or private institution of higher learning and are pursuing a degree in accounting.

Robert & Pauline Hoover Scholarship Endowment was established in 2006 following the death of Robert, as part of his estate plan. Robert was a Chester Township native engaged in farming and banking. Selection for the scholarship is based on academic performance, community service hours, service organization leadership, along with other criteria.

Dennis Horn Cross Country Endowment was established by friends and family of this teacher and coach to recognize his 31 years of cross country coaching at Wabash High School. The fund provides college scholarships to cross country runners and supports the cross country program.

Jo's Hope Scholarship Fund was created in memory of Jolene Kastner Hensley. Jolene is lovingly remembered by family and friends for her honesty, loyalty, sense of humor and leadership. Her greatest interests were family, coaching children and making people smile. The fund provides college scholarships to Manchester High School students pursuing studies in health care or health and wellness.

Mallori L. Kastner Memorial Scholarship Endowment memorializes Mallori Lin Kastner, a 2010 graduate of Wabash High School who attended Grace College and Seminary. Mallori was a statewide volleyball standout and also played basketball and ran track. She was not only a talented athlete, but a dedicated team player and strong leader amongst her peers. The fund provides college scholarships to Wabash High School students who were on the volleyball team throughout their high school career.

Max E. & Grace L. Kester Endowment Fund was established to help level the playing field for female athletes. This scholarship is awarded to the outstanding senior female athlete at Manchester High School who intends to continue her education after high school. The recipient is selected by Manchester High School.

Gene L. & Bertha J. King Scholarship Endowment was established by Gene and Bertha and shall award scholarships to students with financial need from Northfield, Southwood, Wabash, or White's High School who are pursuing a major for a pre-professional career such as education, teaching, law, medicine, pharmacy, science or engineering.

Beryl M. Klare Scholarship was established to assist students with financial need who want to obtain a higher education. With first preference given to residents of the City of Wabash, all residents of Wabash County may be considered. Scholarships are awarded on the basis of financial need.

Karl F. & Bonnie Dee Merritt Manchester University Scholarship Endowment was established to provide support to a student attending Manchester University who has been accepted into the Department of Education in preparation for a teaching career at the elementary or secondary level.

Ted McNabney Spartan Award Endowment was established by Ms. Rebecca Kock who wanted to honor her brother's love of Manchester University and his passion for helping students succeed. To accomplish both, the Ted McNabney Spartan Award Endowment was created, which provides up to a \$2,000 scholarship upon a student's graduation from a Wabash County high school. Students considering this scholarship, must apply during their 8th grade school year, and attend one Manchester University event each semester in high school to earn money that will be placed into their Early Award Scholarship fund held at the Community Foundation.

Ruth M. Minear Educational Scholarship was established to further the post-high school education of any graduating senior of Wabash High School who is worthy of financial help. Scholarships are awarded based on the extent to which a student is prepared or able to succeed in college and the extent to which a student will benefit from financial help.

Dr. Howard & Helen Liebengood Scholarship Endowment was established by the Liebengood family. Eligible applicants are students residing in Kosciusko County who are graduating in the top 20% of their high school class.

Paulus Music Scholarship Endowment was established by Jean E. Paulus in honor of her children, Jay E. Paulus, Kent A. Paulus and Carolyn K. Paulus, all graduates and musicians of York High School in Elmhurst, Illinois. The scholarship will be awarded to the most outstanding graduating senior in the Music Department planning to become a music major in college.

Corlyle K. Paulus Athletic Scholarship was established by Jean E. Paulus in memory of her husband. The scholarship will be awarded to a Manchester High School senior excelling in athletics and planning to study physical education and athletics in college.

The Promise Early Distribution Scholarship Fund provides early award scholarships to Wabash County 4th through 8th graders enrolled in the Promise Scholarship Program who complete in-school assignments, participate in college-go activities and practice regular savings.

Jerry L. Radabaugh Memorial Scholarship Endowment was established by Nancy Radabaugh and provides a scholarship to a student graduating from Northfield or Southwood High School and is pursuing higher education from any accredited university, college or conservatory.

Paul Thomas Reahard Memorial Scholarship Endowment was established by parents Thomas R. and Carolyn Reahard and friends. This scholarship will be made available to a deserving graduate of Whitko or Manchester High School choosing to become a teacher in the area of theatre and drama, as well as English and literature – or for a qualified student desiring to pursue a career in the performing arts. These were life interests of Paul Thomas Reahard.

Dorothy J. & William A. Rice Memorial Scholarship Endowment was established by Gary A. Rice and Randall W. Rice to memorialize their parents, Dorothy and William, who were devoted members of Christ United Methodist Church in Wabash, Indiana. The endowment provides funds to Christ United Methodist Church to be used to award tuition only scholarship grants to members of the church.

John & Edith Richards Memorial Scholarship was established under the terms of their will to assist worthy young residents of Wabash County who have the desire and ability to continue their education beyond high school.

Chris Rood Memorial Baseball Endowment was established by family and friends to memorialize the endeavors of this teacher and coach. The three purposes of the fund are to provide scholarships to baseball players graduating from Wabash High School, to enhance the care and maintenance of the Wabash High School baseball field and to support the Wabash summer instructional baseball league.

George W. & Donna Mae Russell Scholarship Endowment was created through George Russell's estate. This scholarship assists persons who are graduates of Wabash County, Indiana high schools in pursuit of post-secondary education.

Marietta & Paul L. Sell Memorial 4-H Scholarship was established by Doug and Barbara Vawter in memory of Barbara's parents. The Sells modeled the virtues of the 4-H pledge and motto, and believed deeply in giving thanks with grateful hearts. Candidates must have completed a minimum of six years in Indiana 4-H.

Larry Shoemaker Memorial Scholarship Endowment was established by Southwood Music Parents to provide scholarships to graduates of Southwood High School who plan to study music, music technology, music education, sound/music engineering, music performance or some other music discipline in college.

V.A. (Viv) Simmons Scholarship Endowment provides scholarships to current-year graduates of Manchester High School, North Manchester, Indiana, who have demonstrated in school and community life, outstanding performance in scholarship, leadership, service and character.

Una Eileen Slavens Memorial Scholarship Endowment was established by Una's husband Robert and provides scholarships to students who graduate from Wabash High School, Wabash, Indiana, and pursue education studies.

Casey Sparling Memorial Athletic Scholarship Endowment was established by family and friends to memorialize Casey's dedication to athletics as a player and coach. Northfield High School athletes and managers may apply the award to their college of choice.

Todd and Kari Speicher Scholarship was established by the children of Todd and Kari Speicher to honor their parents' work ethic which has done and continues to inspire and set an example for students entering the field of manufacturing and industrial technology.

Dorothy Squires Memorial Scholarship Endowment was created by Fred Squires to memorialize his mother, Dorothy. Scholarships are awarded to any Wabash County high school graduate attending a four-year public or private institution to study any subject.

Blair & Marie Tate Scholarship was established by Marie Tate to help deserving graduates of any Wabash County high school who have financial need obtain an educational or career objective beyond high school.

Franklin S. Tiede Memorial Education Scholarship Endowment was created by parents Charles R. and Julie G. Tiede in memory of their son. It assists persons between the ages of 18 and 25 who are pursuing a vocational or educational objective beyond high school level, which propagation of the Christian faith is the goal.

Leone M. & Inez R. Tyner Scholarship was established by Mr. Tyner in memory of his wife, Inez. The scholarship assists worthy and ambitious students from Wabash County, with preference for those from Lagro Township, to attend a Protestant, Christian college or university.

Harvey V. Underwood Science Scholarship Endowment was created by the family of Harvey Underwood in 2003. It was funded by his family, friends, and colleagues and provides financial assistance to a Manchester High School senior desiring to pursue a four-year science or science education degree.

Wabash County Memorial Scholarship provides a way for contributors to honor and remember those they love and respect. It combines four scholarships that were established to memorialize Dick Harvey, a Manchester Community Schools board member; Kevin Jones, a Wabash County advocate of Big Brothers-Big Sisters; Larry Lauer, the late 4-H leader and mentor; and the late Gladys Harvey, Wabash High School teacher.

Wabash County Society for Crippled Children & Adults Scholarship Endowment was created by the Wabash County Society for Crippled Children and Adults in 2002. The scholarship is awarded to a Manchester, Northfield, or Southwood High School graduate who is pursuing education in a field related to working with children and adults who have learning disabilities or who are mentally and/or physically disabled.

Wabash County Solid Waste Management District Scholarship Endowment provides scholarships to a Wabash County resident who is pursuing a bachelor's degree in environmental studies from an accredited Indiana institution of higher education.

Wabash High School Alumni Scholarship Endowment provides scholarships to individuals, not currently enrolled in college, who have graduated from any of the accredited high schools located in Wabash County, Indiana and who are pursuing a two- or four-year undergraduate degree from an accredited Indiana institution of higher education.

Wabash High School Apache Tennis Scholarship provides scholarships to graduates of Wabash High School who were members of the Tennis team and are pursuing a two- or four-year degree.

Wabash High School Class of 1951 Scholarship Endowment provides scholarships to individuals not currently enrolled in college, who have graduated from any of the accredited high schools located in Wabash County, Indiana, and who are pursuing a two- or four-year undergraduate degree from an accredited Indiana institution of higher education.

Jennie Wade Scholarship was created to assist students in obtaining academic degrees or vocational training that could be used "to benefit mankind." Recipients will be nominated by school officials based on their academic performance or vocational ability.

W. Scott Wakefield Scholarship was created by the Vice and Wakefield families in memory of their son and grandson who lost his life as a young man. The scholarship supports people pursuing an occupational or educational objective beyond high school in a technical or science-related field.

Dallas L. Winchester Scholarship provides scholarships for students who are attending on a full-time basis an Indiana two- or four-year public or private institution. Selection is based on the following factors: demonstrated community service and leadership, in-school leadership, involvement in activities and academics, academic performance, work experience and financial need.

Yopst Educational Scholarship was established to help students obtain an education beyond high school, whether in academic, technical, or vocational fields. This scholarship is awarded to students of good character who have financial need.

NON-PERMANENT FUNDS

Our services also include the administration of non-permanent funds, which typically are only temporarily a part of the Foundation. They may be given to the Foundation for redistribution when certain conditions are met.

Bergstedt-Manchester High School Exchange Fund provides funds to Manchester Community Schools for its high school students who demonstrate financial need and who have been selected by Manchester Community Schools to participate in a short-term educational exchange with students from Bergstedt High School in Hamburg, Germany.

Daniel's Place Fund is committed to providing respite care and support services across the lifespan of persons with physical and intellectual disabilities to enable them to remain in their chosen communities. Respite care gives short-term temporary care to persons whose disabilities are such that they need continual assistance 24 hours a day. Having access to respite care allows caregivers, most often families, an option when they need a break or have tasks that require them to find care for their disabled loved one for a few hours.

Fairview Cemetery Association Fund provides support to the Fairview Cemetery Association to (1) provide an educational benefit to the public and promote an appreciation for community history, (2) combat community deterioration by preserving, beautifying, and maintaining abandoned or deteriorating graves as well as caring for the landscape throughout the cemetery, and (3) lessen the burdens of government by maintaining this semi-public area.

George W. Price Scholarship Fund provides support for early award scholarships to students attending Wabash City Schools in grade 4 who meet the reading criteria as described by the Community Foundation's Early Award Scholarship Program.

Heartland Learning Center Fund provides support to Heartland Career Center to build and equip the new Heartland Learning Center for expanded secondary and post-secondary training in advanced manufacturing and healthcare.

Hope House Wabash County Fund provides support for procuring and operating a women's Hope House sober living home location in Wabash County and providing programming and services at said location.

Nakota Blake Kelly Remembrance Fund will serve to remember Nakota Kelly and provide support to Wabash County organizations and agencies that serve to strengthen, uplift, and provide resources to families and children like Nakota. Some of the organizations that will be supported include Nakota's Neighbors, a new after-school program of the Access Youth Center that will take place in the Meadowbrook Neighborhood, Kids Hope, Blessings in a Backpack, Wabash Little League, and Babe of Wabash County.

Relief and Restore Fund alleviates suffering and financial hardships that are caused by natural disasters, pandemics, and tragedies including but not limited to fires, floods, torrential storms and tornadoes, car accidents, and life threatening disease or extended illness.

Wabash City Schools Foundation Fund focuses on the Wabash City School Corporation's plan to Build a Legacy of Opportunity. The Five Pillars of the plan are wellness, academics, innovations, citizenship, and relationships. These pillars address the physical health and social-emotional well-being of students, while advancing academic rigor, student achievement, and impactful teaching. Additionally, they aim to advance critical thinking skills, civic responsibility, and global perspectives, while supporting programs and initiatives aimed at providing students leading-edge learning opportunities, and building and strengthening relationships will all stakeholders.

Wabash County Lighthouse Missions Growth and Maintenance Fund provides support to Wabash County Lighthouse Mission, Inc. to purchase, improve, and prepare for use their new location on West Canal Street in Wabash, Indiana to carry out its role and mission.


Babe of Wabash County Fund has a mission to create positive, healthy family cultures through building community connections, providing educational materials, and offering resources for families in Wabash County.


